Hotel FAQs

1. What to pack:

- Supply your pet's food in individually labelled ziplock bags (include name & breed).
- Beds, bowls, pillows, etc., are not required. Any extra items must also be clearly labelled.
- We feed only the food you provide.
- WhatsApp updates are welcome; please send a clear message, e.g., "How is Coco, the American Shorthair, eating?"
- 2. What is/are collection/drop off times?

Cattery Operating Hours

- Mon-Sat: Check-in/out 09:00-11:00 | Late check-out (Stay & Play) 16:00-16:30 additional fee
- Sun & Public Holidays: Check-out only 16:00–16:30 | No drop-offs
- Closed: 25 & 26 Dec, 1 Jan (staff on duty; no collections/drop-offs)
- Gates open only during above times for safety and playtime.
- Office phones not monitored on weekends/public holidays; emergencies will be communicated.
- Staff are always on duty; however, the office is unmanned on weekends, so gates remain locked outside specified hours.

3. Health Requirements

All cats must be sterilized, fully vaccinated, and dewormed prior to arrival to protect both your cat and others in our care.

- Annual vaccinations must be up to date.
- Monthly tick, flea, and deworming treatments are required.
- Vaccinations must be administered at least 10 days before arrival.

4. Updates & Photographs

- Photos of your cat are uploaded to the Sloppy Kisses Facebook page. Please download Facebook and like our page to view updates.
- Your cat may not appear in photos every day due to natural movement.
- We cannot send photos directly via email or phone. You may WhatsApp us for updates; responses
 may be delayed during peak season.
- In emergencies, we will contact you directly. (No news is good news.)

5. Identification

- Your cat must wear a collar with a name tag and contact number.
- Provide a clear photo of your cat, and a printed photo with their name for accurate identification.

6. Pet Insurance

- Pet insurance is recommended but not compulsory.
- You are responsible for any expenses in the event your cat injures another pet/person or is injured.

7. Grooming

- We recommend grooming your cat before collection, as they may get dirty during their stay.
- A 50% discount on hotel grooming is offered if booked at the time of check-in or reservation.

8. Post-Cattery Adjustment

 Upon returning home, keep your cat indoors for a few days to help them readjust to their environment.

9. What to Pack

- Food with clear feeding instructions.
- Travel box for safe transport between your car and the cattery.

- 10. Cattery Operations
- Cats roam freely in the cattery, monitored by handlers to ensure they are safe, eating well, and stress-free.
- Maximum of 15 cats in the cattery at any time.
- Our staff work long hours, 7 days a week, to provide the best care.
